**Sampling Design :**

**Category 1 :**

Those industry groups ( or strata ) where the number of factories is 20 or less are designated as Complete Enumeration(CE) category.

**Category 2 :**

Those strata where the number of units , within each stratum, is between 21 and 60, are said to form segment S1.

**Category 3 :**

Those strata where the number of factories , within each stratum, is 61 and/or more, are known to be in segment S2.

**Census Sector :**

All the factories in the Census Sector together with all the electricity undertaking and all the factories located in relatively less industrialised states and union territories( listed in the survey year) for the sample sector continue to be enumerated every year. Apart from these, factories falling under category 1 in the above paragraph have also been completely enumerated in the current survey.
